What we achieved across our CARE pillars of Collaboration Advocacy Research Education...








Lucy's Project collaborated with organisations across the DFV, community, homelessness, animal welfare and veterinary service sectors across all areas of our work including advocacy, research and education. Below we have highlighted some of our key collaborative advocacy achievements:

- Collaborated with 6 organisations to advocate for legislative changes in NSW to improve access to rental housing for people with animals experiencing DFV. These changes came into effect in May 2025.
- Collaborated with 5 organisations to advocate for family law courts to prioritise the safety of victim-survivors when making decisions about animals as property. The changes came into effect in June 2025.
- Collaborated with 6 organisations to advocate for changes in Tasmania to ensure animal abuse is recognised as a form of DFV in law. These changes came into effect in November 2024.







Lucy's Project made evidence-based policy submissions and provided input for:

- NSW Homelessness Strategy 2025-2035 which led to a commitment in the strategy to ensure people with animals can access crisis accommodation.
- NSW Domestic Violence Safety Assessment Tool Redesign which ensured that services are required to ask victim-survivors about any harm or threats to harm companion, assistance, farmed and wild animals.
- NSW Common Risk Assessment and Management Framework which ensured that veterinary professionals are included as responders to DFV.
- NSW Rental Commissioner and Fair Trading consultation which led to changes to make it easier for people to rent with companion animals.
- Federal Parliamentary Inquiry into Family Violence Orders which led to the Committee recommending that risk assessments address harm to animals, and that training about animal abuse be provided to judges and lawyers.
- Federal Parliamentary Inquiry into Family Law Amendment Bill and provided evidence at the Senate Hearing which ensured that companion animals can be transferred to a family member or friend, instead of having to be sold, if the court decides neither party should own the animal.
- National Roundtable into Healing and Recovery to ensure recognition that people and animals should be supported to heal and recover together.
- SA Royal Commission into DFSV which led to the recommendation that the risk assessment framework must identify and respond to animal abuse.
- TAS Family Violence Amendment Bill 2024 which led to changes to the law to ensure that animal abuse is recognised as a form of DFV. Lucy's Project role in driving the change was acknowledged in a speech in parliament.
- Commonwealth and State and Territory Budgets for 2025-2026 to ensure that governments are aware of the need to fund services to support people and animals experiencing DFV.





Lucy's Project delivered a Parliamentary Briefing with the NSW Parliamentary Friends of Prevention of Domestic Violence and Sexual Assault, supported by the co-chairs the Hon. Natasha Maclaren-Jones MLC and Trish Doyle MP.

Join us for a briefing about domestic and family violence perpetrated against people and animals

THURSDAY 5 JUNE 12.30 to 1.30pm MACQUARIE ROOM



This briefing will cover:

- An introduction to Lucy's Project and the impact of our work
- The nature of DFV perpetrated against people and animals
- Perpetrators' use of animal abuse as part of coercive control
- Issues and barriers to safety for people and animals
- Solutions for improving the safety of people and animals







Lucy's Project organised 2 day conference to bring together over 30 speakers and 120 attendees to share research and practice insights.

The participants work in the DFV, community, veterinary, animal welfare, university, TAFE, legal, and government sectors.

90% of participants said the conference increased their understanding of emerging and better practices for supporting people and animals experiencing DFV.

Participants said they were inspired to take the following actions:

- Advocate for policy and practice changes within their service
- Include animals during intake, risk assessment, safety planning
- Educate their teams and share insights with their colleagues
- Collaborate across human and animal services
- Develop or expand emergency boarding and care programs
- Undertake research on issues raised during the conference

Lucy's Project partnered with White & Case LLP International Law Firm who undertook extensive legal research on a pro bono basis for Lucy's Project.

Lucy's Project asked White & Case to provide a comprehensive overview of relevant laws across the Commonwealth and state and territory jurisdictions to respond to the following questions:

- What provisions exist in DFV-related legislation regarding violence or threats of violence against animals?
- How do Apprehended Violence Orders (AVOs) and equivalent legal instruments provide protection for animals or people with animals?
- What are the current laws regarding the right of tenants experiencing DFV to keep animals in residential premises?
- Under the amended Family Law Act, how are companion animals treated in property settlements or custody matters in DFV contexts?
- Are there specific legal mechanisms for determining "custody" or care arrangements of animals post-separation in DFV-related family law proceedings?
- What are the laws regarding ownership, registration, and microchipping of companion and farmed animals?
- In cases of DFV, what legal hurdles exist in proving ownership or reclaiming animals legally classified as "property"?
- What protections are afforded under any Animal Cruelty Legislation or equivalent acts? Do these protections extend to animals experiencing or exposed to DFV (companion, assistance, farmed, and wild animals)?
- What anti-discrimination protections exist for individuals with assistance animals?
- Are there inconsistencies (if any) between federal and state/territory laws that may impact victims of DFV with assistance animals?
- What legal avenues are available for addressing harm to wild animals in the context of DFV?

The legal research will be highly valuable for informing Lucy's Project's policy submissions and advocacy for legislative reform to improve the safety and wellbeing of people and animals experiencing DFV across Australia.





Lucy's Project delivered 24 education sessions to 691 participants working in the DFV, homelessness, community, animal welfare, veterinary and local government sectors.

- 92% of participants said that their understanding of DFV perpetrated against people and animals had improved.
- 98% of participants said they now have a better understanding of animal inclusive intake, risk assessment and safety planning.
- 100% of participants said that their knowledge of the barriers faced by people and animals experiencing DFV had improved.

Participants said they would make changes to their practice to include questions about animals and animal abuse during intake, risk assessment and safety planning.

Raising awareness through social media

Over the past year, Lucy's Project has seen significant growth across our communications channels, reflecting the impact of our renewed digital strategy. With a stronger focus on consistency, skills development, and expanding our online presence, we've been able to connect more deeply with our community and amplify the message that safety for all victim-survivors, including animals, is possible.

Our social channels saw steady and meaningful increases in both reach and followers. Instagram reach grew by 27.69%, while Facebook reach rose by an impressive 53.60%. We also strengthened our core supporter community, with Instagram followers increasing by 47.81% and Facebook followers by 12.3%.

Engagement tells an even more encouraging story. Content interactions surged—by 122.17% on Instagram and 56.52% on Facebook—demonstrating that our messaging is resonating more strongly than ever. Content sharing on Instagram also increased dramatically by 535.72%, helping further extend our reach and awareness of animal-inclusive safety.

This year, several posts significantly outperformed our usual metrics, demonstrating the impact of strategic content design, sector partnerships, and selective paid promotion. Across our top posts, we saw strong reach, high view counts, and meaningful interaction rates, with several posts generating 2,000 to 4,380 views and others driving remarkable engagement relative to audience size.


We also expanded our electronic mailing list, with email subscribers increasing by 21.25%. This growth strengthens our ability to maintain ongoing conversations with supporters, provide updates on our advocacy, and invite more people to be part of the movement for safety and change.


These results reflect the power of a thoughtful, strategy-driven approach—and highlight the growing community of people committed to helping us build a future where no victim-survivor, human or animal, is left behind.

We have continued to strengthen our social media strategies by deepening supporter engagement, enhancing supporter experience, and positioning Lucy's Project as a sector leader in animal-inclusive domestic and family violence responses. We aim to achieve this by maintaining a strong, adaptable social media strategy that keeps pace with a fast-moving digital landscape. Our content and engagement approach have continued to be reviewed to ensure it reflects emerging goals, tools, and opportunities for impact.




